Maternal and child mortality is unacceptably high. In 2015, over 300,000 women died during and following pregnancy and childbirth and infant mortality amounted to 4.5 million. Almost all of these deaths occurred in low-resource settings, and most could have been prevented through simple, affordable interventions.

Professional assistance at point of care and access to basic health commodities before, during and after childbirth save the lives of women and infants and ensure survival during the critical first five years. - A child whose mother dies during childbirth is 3-10 times more likely to die before his or her second birthday.
